THESE PROJECTS PROTECT 37.5 ACRES OF AN EXCEPTIONAL POTHOLE WETLAND THAT IS CRITICAL FOR TENS OF THOUSANDS OF MIGRATORY WATERFOWL, OVER 20 SPECIES OF SHOREBIRDS, AND HUNDREDS OF MIGRATING SANDHILL CRANES EACH YEAR.
